



On December 10, 2015, Defendant filed a timely post trial motion for a new trial based on insufficient evidence. On February 11, 2016, Defendant's motion for a new trial was heard and denied by The Honorable Roger M. Young.

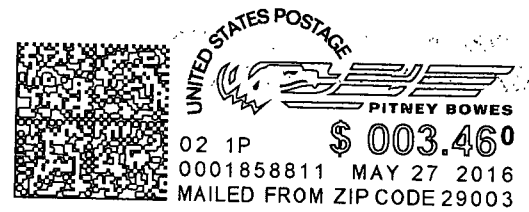
