

NOTICE OF APPEAL

Ray Lee Dominick, Jr., appeals his guilty conviction on May 17, 2016, in Newberry County for the offense of Assault and Battery High and Aggravated, in the above guilty plea and the sentences therefore. Appellant was sentenced to Fourteen and a half (14 1/2) Years imprisonment by the Honorable Donald B. Hocker, on May 17, 2016.

This appeal arises from a guilty plea and is filed pursuant to notification from Appellant by letter dated May 23, 2016, indicating that Appellant wishes to appeal his guilty plea. 
