
Pursuant to Rules 240 and 260, SCACR, the South Carolina Cable Television Association, the South Carolina Telephone Coalition, and the South Carolina Office of Regulatory Staff (collectively "Moving Parties") move to dismiss this appeal. The Court previously issued orders staying this appeal on January 14, 2015 and July 23, 2015. The Moving Parties now request that the appeal be dismissed as explained below.

As explained in their original motion to stay, the Moving Parties, along with BellSouth Telecommunications, LLC doing business as AT&T South Carolina, have supported proposed legislation that would, among other things, resolve the issues that are the subject of this appeal. The proposed legislation, Senate Bill Number 277, was signed by the Governor on May 25, 2016, and enrolled as Act 181 on May 31, 2016.

As indicated in prior motions seeking to stay this appeal, the Moving Parties report to the Court of the enactment of Act No. 181 and seek to have the appeal dismissed. The Appellant has notified counsel for the other parties in the Public Service Commission docket of our intent to file this motion and has not received any objection. For these reasons, the Moving Parties respectfully request that the appeal be dismissed.
