**MOTION TO REQUIRE APPELLANT TO FILE A CORRECTED OR  
SUPPLEMENTAL RECORD ON APPEAL**

Comes now Respondent, through undersigned counsel, and requests that this Court require Appellant to file a corrected or supplemental Record on Appeal. The relevant facts supporting this request are as follows.


Appellant served an Amended Record on Appeal on April 27, 2016, in response to a letter from the Court dated April 15, 2016. The Amended Record on Appeal, as received by Respondent, is clearly missing two pages of the disciplinary hearing transcript; specifically, pages two and three. (See Amended Record on Appeal at pages 6 and 9). Due to these missing pages, Respondent is unable to file and serve a proper Final Brief of Respondent, as these pages were cited to repeatedly in Respondent's Brief. (See

Initial Brief of Respondent, pages 4-5.) Accordingly, Respondent requests that this Court require Appellant to file another Amended Record on Appeal or at least a Supplemental Record on Appeal so that Respondent may file a proper Final Brief. Respondent would further request that Appellant be required to include in the Record all items designated in Respondent's Designation of Matter filed March 18, 2016, as required by South Carolina Appellate Court Rule 210(c) ("The Record on Appeal shall include *all matter designated to be included by any party* under Rule 209 . . . .") (emphasis added).

Respondent respectfully requests that this Court hold the time period for filing the Final Brief of Respondent an abeyance pending the resolution of this motion.



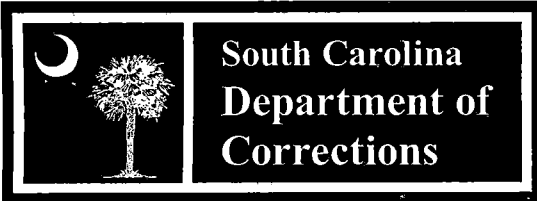
