



in the following particulars:

DESCRIPTION OF OFFENSE: Burglary / Burglary (After June 20, 1985) - First degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

Based on an investigation by the OCSO, the affiant states and verily believes that the subject, Mr. JB Young did commit the crime of Burglary First degree and that probable cause is based on the following facts. Mr. Young did willingly and unlawfully enter the dwelling of the victim, Robert Summers without his consent with the intent to commit a crime. Mr. Young forced entry into the residence and took a RCA cable box and 2 TV antennas from inside the residence. Mr. Young then went into the back shed and forced open a cabinet and took an orange extension cord, bow saw, and an air compressor. Affiant was able to recover the above stolen property from Mr. Young's residence at 145 Root Road, by Mr. Young's own admission. Additionally, Mr. Young had a prior conviction for housebreaking and a prior conviction for Burglary which enhances this crime from Burglary 2nd to a Burglary 1st. This crime was committed on Sector Road in the county of Orangeburg and is violation of SC Code of Laws, as amended.
