
**THIRD AND FINAL UNOPPOSED PETITION FOR EXTENSION TO FILE

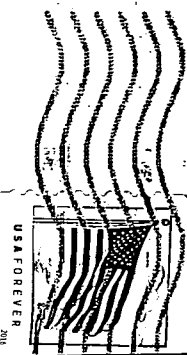
