
Dear Regina Hollins Lewis:

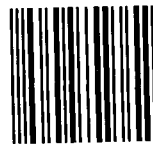
