APPELLANT'S MOTION FOR EXTENSION TO FILE INITIAL BRIEF


Appellant received the transcript of hearing on May 9, 2016, making Appellant's Initial Brief due on June 8, 2016. On June 1, 2016 the undersigned wrote the Court of Appeals advising that Respondent, Jennifer R. Bergmann, filed for bankruptcy (Ch. 7) on May 6, 2016, Case No. 16-02250-dd. It is the undersigned's understanding that under 11 U.S. Code § 362 of the Bankruptcy Code, the filing of bankruptcy stays the continuation of any judicial proceeding against Ms. Bergmann, the bankruptcy debtor and Respondent in this Appeal. It is Appellant's understanding that the Court of Appeals is reviewing this matter to determine if the bankruptcy stay applies, and Appellant, therefore, respectfully requests a sixty (60) day extension to file and serve Appellant's Initial Brief. 


