I have received today your letter dated May 2, 2016 and postmarked May 10, 2016, requesting "the entire transcript of the proceedings" in Case No. 2014-CP-07-00426, Ronald Ford and Sonya Ford v. Taiwan R. Scott (2016-000245). I called and left you a voice message this morning. I am following up with this email and will place a copy of this email in the mail to you at 49 Oakview Road, Hilton Head Island, SC 29926.

As we discussed in our emails and phone calls of January 2016 and April 2016, I will require your advance payment of \$525 in the form of cash or certified funds, money order or cashier's check, before I will begin work on your transcripts. It will take 2-4 weeks from the time I receive your payment to complete each transcript depending on my workload. My estimate is as follows:

The 01/16/16 follow-up hearing on motions was approximately 30 minutes long. I estimate that transcript to be approximately \$150.

The 10/03/14 final hearing was approximately 90 minutes long. I estimate that transcript to be approximately \$375-450. The 10/07/15 motion hearing was scheduled but not heard, so there is not a transcript that can be prepared.

Also, your letter of May 2nd references Rule 607. I am not a SC State employee. As a former SC State official court reporter, I tend to use Rule 607 as my guideline in all aspects of my court reporting. I would ask that we note that on your May 2nd letter and you initial it when you bring in your prepayment.

It would be best if you would come by the office one morning. I try to schedule my personal appointments in the afternoons and if the docket falls off, then I may leave early that afternoon. I look forward to hearing from you.

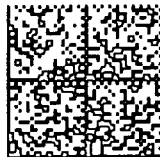
