Please note that the Respondents have not requested any prior extensions for this brief.



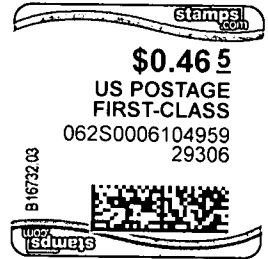
