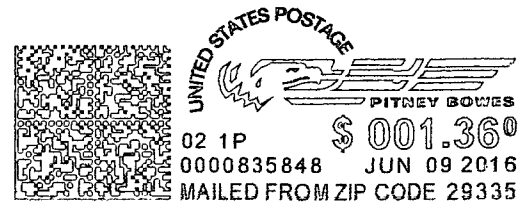
I needed the library to use the rules of civil and criminal procedure manuals and to research the cases Judge Kelly cited in his order.

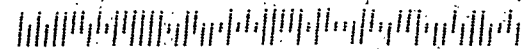
