COME NOW RESPONDENTS and respectfully file this Motion for Leave to File their Final Brief Outside the Filing Deadlines Set Forth by Rule 211, SCACR, as requested by the May 31, 2016 correspondence from the Clerk of Court of the South Carolina Court of Appeals received by counsel for Respondents.

Respondents filed their Initial Brief on March 17, 2016. On April 18, 2016, Appellant filed the Record on Appeal, consisting only of the lower court's May 22, 2015 Order Granting Defendants' Motions for Summary Judgment. The only citations included in Respondents' Initial Brief were to this May 22, 2015 Order (cited in the Initial brief as "R. at \_\_") and to the Hearing Transcript, which Appellant did not include in the Record on Appeal.

In accordance with Rule 211, SCACR, Respondents' Final Brief is identical to their initial brief served under Rule 208, except that the references in the initial brief have been revised to indicate where the material appears in the Record on Appeal. Citations to the Hearing Transcript, which was not included in the Record on Appeal, have been removed. Given that Respondents' Initial Brief and Final Brief are identical (except for the changes to references as provided in Rule 211, SCACR), Appellant will suffer no prejudice by Respondents' being permitted to file their Final Brief.

Accordingly, Respondents respectfully request that they be permitted to file their Final Brief outside of the filing deadlines set by Rule 211, SCACR.



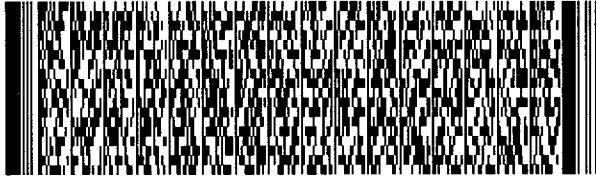

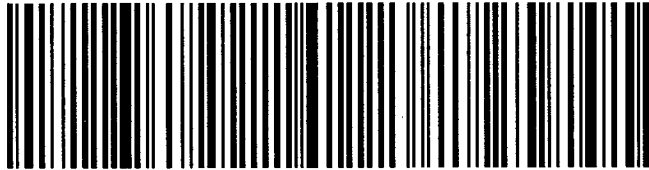
