

Jonathan Jamison appeals his conviction and sentence in this case. The sentence was imposed by the Honorable Edgar W. Dickson on April 29, 2016.

When asked by his undersigned counsel to provide the explanation for this appeal as required by Appellate Court Rule 203 (d)(1)(B)(iv), the appellant replied, "that's too much time". Counsel explained that the given 13 years sentence was within the 7 years minimum to 25-30 years maximum sentence authorized for his conviction, and therefore, was a legal sentence. The appellant insisted that counsel file the appeal anyway. Therefore, this appeal was filed by counsel to avoid any possible administrative complaints or assertions of ineffective assistance of counsel.
