
Dear Mr. Shearouse:

Appellate Case No. 2016-000839 was appealed from the Public Service Commission of South Carolina ("PSC"), Docket No. 2013-392-E. 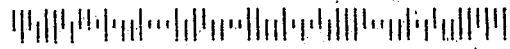
