MOTION FOR JURISDICTION, ETC.

Jacqueline Tedder, Petitioner is in receipt of this Court's Order dated June 1, 2016 in which this Court acknowledges that this matter was affirmed by the South Carolina Court of Appeals in an opinion filed April 20, 2016, that the Court of Appeals refused to hear petitioner's pro se motion for reconsideration en banc, filed May 9, 2016, after the Court of Appeals sent the remittitur to the circuit court on May 6, 2016. 

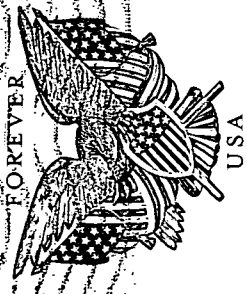
