Dear Ms. Kitchings:

I am responding to your letter dated June 13, 2016, informing the parties that the Court may consider the above-captioned case during the September or October 2016 term of Court and asking for any conflicts on those dates. Counsel has no conflicts on September 6, 7 and 21 or October 11, 12 and 13.

Thank you very much for your kind cooperation and assistance.

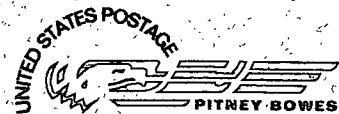
