Appellant asks permission to withdraw Facts page 4 and 5 of briefs containing errors and replace Facts page 4 and 5 with no errors.


1. Background. The appellant timely filed a final brief on June 4, 2016. This case has not yet been set for argument.

2. Reasons. After the brief was filed, appellant, Tommy J. Bellamy Pro se discovered typographical errors in four exhibit case citations on Facts pages 4 and 5 of briefs. **Number 2. Exhibit (3)** quit claim deed Tommy J. Bellamy to LLC (October 4, 2007), **Number 3. Exhibit (6)** quit claim deed LLC to Tommy J. Bellamy (February 10 2010), **Number 7. Exhibit (7)** Final Appeal to Horry County Board of Assessment (May 12, 2015) and Facts page 5 **Number 10. Exhibit (2)** Tommy J. Bellamy appeal to Administrative law Judge.

In addition, appellant discovered this mistake after the original copies had been filed with the clerk of the appellate courts.

3. These errors cannot be corrected in the office of the clerk of the appellate courts. Instead an entirely new Facts page 4 and 5 of briefs, with corrections and proper collation, have been prepared for substitution for the briefs now filed with the Court.


