Counsel filed the petition for writ of certiorari to the Court of Appeals in the case of State v. Brett Parker in this Court on May 11, 2016, as a co-counsel with Robert M. Dudek and David Alexander. Counsel filed the petition for rehearing in the case of State v. James Simmons in the Court of Appeals on May 5, 2016. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Kendall Tyus in the Court of Appeals on May 4, 2016. Counsel filed the brief of petitioner in the case of State v. Walter M. Bash in this Court on April 25, 2016.


3. This request is made in good faith, and not for purposes of delay.

4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.




