This action came to trial or hearing before the court. The issues have been tried or heard and a decision rendered.

Defendant's Motion to Dismiss is denied. Based on the allegations set forth in the complaint, personal jurisdiction exists in South Carolina over both defendants, and Plaintiff has sufficiently stated a claim against Defendant for unjust enrichment and quantum meruit. South Carolina law under S.C. Code 15-7-20 and 15-7-30 permits Plaintiff to bring action in Greenville County.
