I was embarrassed, humiliated by the Defendant's defamation.


I was portrayed me as a thief.

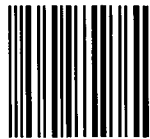
