


Dear Ms. Jenkins:



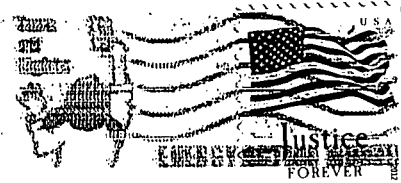
