The Appellant Pro Se in the above captioned case makes this appeal for an impartial review of his lawsuit in the Court of Common Pleas, Greenville. The Appellant again, cites a bias and prejudice against the Plaintiff Pro Se. Prior to any action by the Appellant, he served a complaint letter to Dr Barksdale requesting that she remove and purge such fabrications from his medical records. Dr Barksdale did not respond to his letter. On December 14, 2015 I filed the lawsuit against Dr Barksdale of Barksdale

17 to return to work cannot because of Dr Barksdale's  
18 actions damaging his reputation and character.  
19 Dr Barksdale did this only after he  
20 confided to her that he continued to have  
21 his privacy invaded by a large university  
22 medical center in California. It is true  
23 that Loma Linda University Medical Center  
24 and their religious arm are using their  
25 Fcc licensed satellite transmitter in


