
Dear Ms. Tucker:

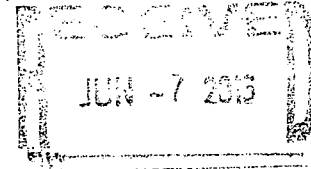



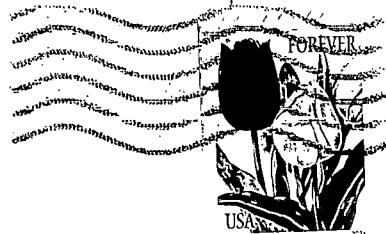
