
Dear Clerk Kitchings:


Pursuant to Rule 260(b) and 261(a) of the South Carolina Appellate Court Rules, the



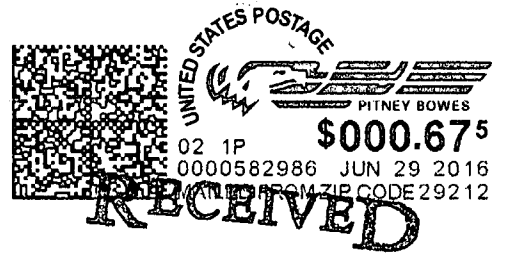
