
**RESPONDENT'S MOTION TO ALLOW LATE FILING**

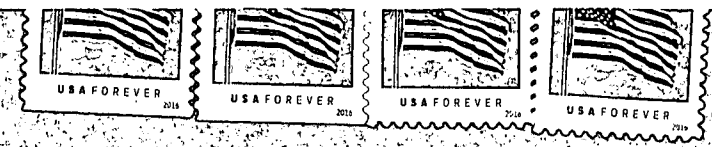
