To Him That I Knew Nothing About SC Law, & That I Also Knew Of The Violation Under The 14TH Amendment Of My Procedural Due Process Rights.

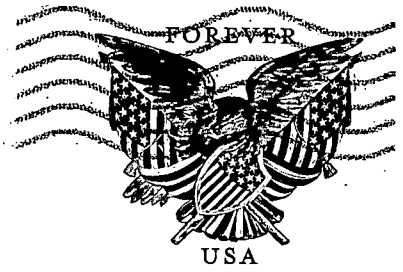
