Counsels have proposed the following date as the deadline for filing Defendant's Reply Brief:





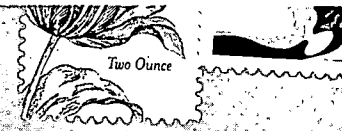
