1. I'm charged with Attempted Arm Robbery. When the victim stated that the suspect did not ask for any money. During her testimony and statement.
2. There was no evidence presented inside the courtroom, only a video was seen.
3. I'm charged with Possession of a firearm by Person Prohibited and Possession of a Weapon During a Violent Crime. When there was no gun recovered into evidence.
4. The solicitor did not read out the victim or witness statement inside the courtroom.
5. The victim and witness statement do not match up.
6. The tattoo in the video does not match up. Inside the video the tattoo shown on camera does not completely match up to the tattoo that's on my forearm.
7. Also inside the video the man on camera has a half of face shown, and also the victim or witness could not identify the suspect inside of a photo line up.
8. The solicitor stated that a gun was fired but it show nowhere inside the video the gun being fired.
9. There was no GSR recovered.

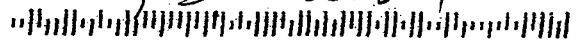
