

The Applicant was present at the hearing and represented by David K. Allen, Esquire. Patrick Schneckpeper, Esquire, of the South Carolina Attorney General's Office, represented the State. The Court denied relief by an order dated April 18, 2016, and filed April 29, 2016. Applicant subsequently filed a motion asking the Court to reconsider the findings of fact and conclusions of law contained in the order of dismissal. 

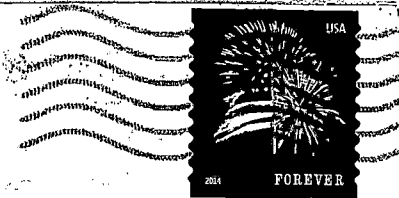
