
I trust this letter finds you well. Please find enclosed for filing, an amended proof of service in this matter.

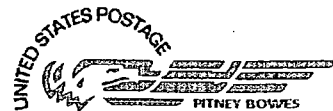
