
MOTION TO ORDER TRANSCRIPT OUT OF TIME



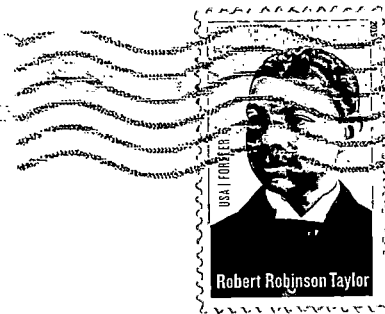
