
NOTICE OF APPEAL

Cardinal Logistics Management Corporation and Ronnie Clark (collectively "Appellants") appeal the February 5, 2015 Order of the Honorable Franklin B. Joyner, granting a default judgment against Appellants. The Appeal is timely pursuant to Rule 203, SCRAP following receipt of the denial of Appellants' motion to alter or amend the judgment. A copy of the Order of Default Judgment and Order Denying Appellants' Motion to Alter or Amend Judgment are attached as Exhibits A and B. 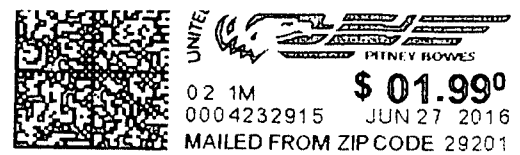
