
**RESPONDENTS SHOPE RENO WARTON AND RUSS COOPER ASSOCIATES, INC.'S



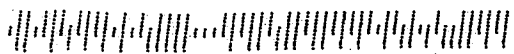
