This is to acknowledge receipt of your July 7, 2016, letter concerning the transcript in the above-captioned matter. Please be advised that the transcript has not yet been delivered. This is the case because, as shown below, Ms. Cross believes that it is not due until August 4, 2016. Her basis for this belief and the sequence of events concerning the transcript are as follows:

The notice of appeal was filed in the case by letter dated April 25, 2016. Thereafter, by letter dated April 28, 2016, we requested that Ms. Cross provide us with a copy of the transcript. In response, by email dated May 3, 2016, Ms. Cross indicated that she had received our request on May 2nd and requested a deposit in the amount of \$137.00. Subsequently, by email dated May 4, 2016, we requested a W9 so that we could issue a check and pay her the deposit. Having not received that W9, we sent another email dated May 23, 2016, requesting it once again.

Subsequently, we received the W9 on May 30, 2016. Thereafter, by letter dated June 1, 2016, we forwarded a check in the amount of \$137.00 to Ms. Cross. We then sent a follow-up email on July 9, 2016, inquiring as to the status of the transcript. In response, we received an email from Ms. Cross dated July 12, 2016 wherein she indicated that she had been out of town but would check on our request. Thereafter, by email dated July 15, 2016, she indicated that she received the deposit on June 4, 2016 and that the due date for the transcript is August 4, 2016. She also noted that she has several requests ahead of ours and may need an extension. For your


