NOTICE OF APPEAL


Appellant, William F. Poston, Claimant, appeals the Order of the Appellate Panel of the South Carolina Workers' Compensation Commission dated July 6, 2016, on the following grounds:

1. THE COMMISSION ERRED AS A MATTER OF FACT AND CONCLUSION OF LAW IN FINDING THAT CLAIMANT'S DISEASE DID NOT ARISE OUT OF OR IN THE COURSE OF EMPLOYMENT.
2. THE COMMISSION ERRED AS A MATTER OF FACT AND CONCLUSION OF LAW IN FINDING THAT THE DISEASE CLAIMANT CONTRACTED IS NOT PECULIAR TO HIS EMPLOYMENT.
3. THE COMMISSION ERRED AS A MATTER OF FACT AND CONCLUSION OF LAW IN FINDING THAT UNDER §42-11-10 CLAIMANT DID NOT SUFFER AN OCCUPATIONAL DISEASE AND IS NOT ENTITLED TO REIMBURSEMENT FOR ANY PREVIOUS

MEDICAL TREATMENT, AND IS NOT ENTITLED TO
ANY FURTHER MEDICAL TREATMENT.


