Janoblin Maurice Bracy-Brown appeals his conviction and sentence in this case. He pled in March 14, 2013 before The Honorable Thomas W. Cooper, Jr. while represented by James Cooper. His sentence was deferred and he was sentenced on June 4, 2014 before The Honorable Letitia H. Verdin while represented by Jennifer Davis. A motion to reconsider was filed June 11, 2014. Defendant was unaware the motion to reconsider was denied on July 8, 2014 until actual notice on July 19, 2016 when the Order (attached) was located in the Clerk of Court's Office in Richland County. Defense counsel nor the prosecution received written notice of the denial.

Defendant believes the Notice of Appeal is still timely under South Carolina Appellate Court Rule 203 (b)(2).


