If you have any questions concerning this matter, please do not hesitate to contact me.

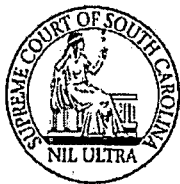

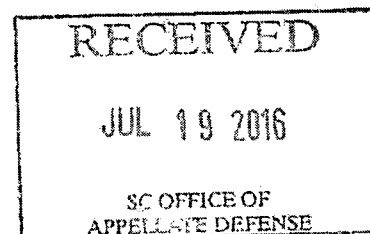

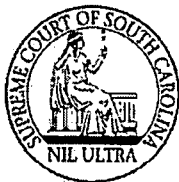
