

AMENDED NOTICE OF APPEAL

PLEASE TAKE NOTICE that Roger Baughman hereby appeals his sentence of ten (10) years in the South Carolina Department of Corrections on the first count of Sexual Exploitation of Minor, 2nd Degree, ten (10) years in the South Carolina Department of Corrections on the first count of Sexual Exploitation of a Minor, 3rd Degree, to be served consecutively, and ten (10) years each on all remaining counts to be served concurrently with the above sentences which was entered by the Honorable Clifton Newman on September 13, 2012. The Defendant's grounds for this appeal include, but are not limited to, that the imposed sentence appears inequitable and excessive given the Defendant's diagnosed mental health issues, his consistent rehabilitation throughout the pendency of these charges, as well as the lack of evidence of a reoccurrence of

the behavior leading to these charges. A timely Motion for Reconsideration was filed on September 21, 2012 and served on all parties. The Honorable Clifton Newman denied said Motion for Reconsideration on October 12, 2012. Please take further notice that Roger Baughman hereby appeals the denial of his Motion for Reconsideration by The Honorable Clifton Newman. Trial counsel for the Appellant received the Order Denying Motion to Reconsider on October 16, 2012.
