
The underlying action is captioned In Re: The Estate of James Brown a/k/a James Joseph Brown. However, I did not want the caption of this matter to be confused with the other pending appellate action 2015-002417. That matter is currently pending before the Court and arises out of the same underlying lower court case. Yet, the parties to this appeal are not the same as the 2015-002417 case as the issues in this appeal involve separate matters and a subset of the parties from the lower court case.

As the enclosed Joint Motion was only filed on behalf of certain parties (footnote 2 of the Joint Motion clearly indicates that Tommie Rae Hynie Brown's claims are not settled by the motion), certain parties in the underlying civil action would not be a part of this appeal. As a result, I captioned the matter In Re: Estate of James Brown a/k/a James Joseph Brown. I labeled all parties who approved or joined in the Joint Motion as Respondents. The only parties that

opposed the Joint Motion in the lower court were Terry Brown and Darryl Brown. As a result, I labeled them Appellants for this matter. Tommie Rae Hynie Brown and James Brown II were excluded from the appeal as they were not part of the underlying Joint Motion and did not file an objection.

After reviewing the above and the enclosed Joint Motion, please let me know if the caption as it stands needs to be adjusted. Thank you.
