Now comes the Appellant before this honorable court to seek Justice and Review in the matter of his sentence-related-statutorily-provided-time-credits conferred by S.C. Code Ann. §§ 24-13-210(b) and 24-13-230(b). The Respondent has illegally calculated/miscalculated the Appellant's time and pushed his release date backwards eight(8) months and forcing him to stay incarcerated past the 85% imposed by the courts at his conviction in 2006.
