Dear Petitioners:

This Court has received your petition for a writ of certiorari and appendix, and the case has been assigned the appellate case number that appears above. Please use this number on all future correspondence relating to this matter.

Please be advised that your filings do not comply with the requirements of Rule 242 of the South Carolina Appellate Court Rules (SCACR).¹ Instead, you will need to file a petition for a writ of certiorari and appendix that are separate documents.

The petition for a writ of certiorari must contain the information specified in Rule 242(d). Form 18 in Appendix C to Part II of the SCACR contains an example of the format for a petition for a writ of certiorari to the South Carolina Court of Appeals, and I would strongly encourage you to follow this suggested format. I have enclosed a copy of Rule 242 along with a copy of Form 18.

The appendix must contain the documents specified in Rule 242(e).

Within twenty (20) days of the date of this letter, you will need to file a revised petition for a writ of certiorari and a revised appendix with this Court that fully comply with the requirements of Rule 242, SCACR. Please file the number of copies specified in Rule 242(c) and (e) for each document. Also, at that same time, you will need to provide a proof of service showing that a copy of the revised petition for a writ of certiorari has been served on opposing counsel. Failure to do so may result in the dismissal of this matter.

All parties are advised that all filings must comply with the requirements of Rule 267 of the South Carolina Appellate Court Rules (SCACR). Additionally, any filings submitted by counsel admitted in South Carolina must include counsel's bar number.

The attention of the parties is directed to the order relating to the inclusion of personal data identifiers and other sensitive information in documents filed with the Supreme Court of South Carolina and the South Carolina Court of Appeals. The order can be found at www.sccourts.org/courtOrders/HTMLFiles/2007-08-13-02.htm. Please note that the responsibility for insuring that information is redacted or sealed as required by this order rests with counsel and the parties. This office will *not* review filings for redaction or to determine if materials should be sealed.
