

203(B)(IV)



The undersigned is informed and believes that the appellant wishes to appeal the effectiveness of his Drug Court Termination counsel and the length of his sentence itself.


The undersigned is not aware of any argument or citation to legal authority showing how these issues can be reviewed on appeal as required by Appellate Court Rule 203 (B) (IV).

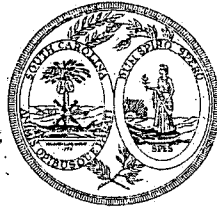
