
I received this court's letter of deficiencies

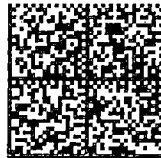
