Dear Clerk.

On June 9, 2016 I went to Richland County Court of Common Pleas on case # 2015-CP-40-6789 a personal property tort claim. My case was dismissed on June 14, 2016. I received notice on June 21, 2016. On June 21, 2016 I drew up a 59(e) motion and placed it in the institutional mail. The costs were debited to my account and the motion was stamped by the mailroom on June 22, 2016. Pursuant to Rule 59(e) I properly filed the motion before the allotted 10 days to file. Pursuant to Rule 59(f) I served the circuit judge as well. I've wrote numerous times in attempts to get a ruling. This motion is being ignored by Richland County. They keep sending me paperwork stating this case 2015-CP-40-6789 is dismissed. I reference the 59(e) motion and its being ignored. I followed all rules pursuant to SCRPC Rule 59(e) and 59(f) but the Courts are ignoring my motion. I filed Notice of Intent to Appeal today of August 1, 2016. I served the S.C. Court of Appeals and Richland County Court of Common Pleas. I in NO way want to abandon by properly filed 59(e) motion. The Courts ruled on dismissing my case initially on 6-14-16. But they REFUSE to give me a ruling on my 59(e) motion. If the Honorable Court of Appeals get Richland County Courthouse to rule on this motion I will stop the appeal I filed in order to get a ruling on my 59(e) motion so I can reserve my rights and issues raised at the hearing. I pray this letter finds you and that the Honorable Court of Appeals can assist with this matter.
