Dear Dr. Battersby:

I am in receipt of your letter requesting the above-referenced transcript. I have reviewed my records and estimate that the transcript for the hearing in the above referenced case before the Honorable R. Lawton McIntosh on January 25, 2016, will be 50 pages. Based on the current rate of \$3.25 per page, the cost will be \$162.50 plus \$6.45 for postage.

Under our rules, I have 60 days in which to complete a transcript. Upon receipt of a certified check or money order (no personal checks, please) for \$168.95, the 60 days begin. If I have underestimated the number of pages, you will be notified prior to delivery of the transcript of the balance due. If I have overestimated the number of pages, you will be refunded the overpayment.

The length of time it takes to prepare a transcript depends on my current typing load and number of days in court. In the event I need an extension of time to complete the transcript, I will request an extension from Court Administration. You will be notified if the extension is granted.

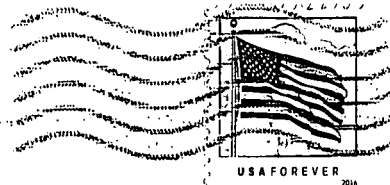
