My investigation turned up no "special" rules for people to use to petition the Supreme Court of South Carolina to get justice when their human rights are being illegally violated. I spoke with a couple clerks of court and the librarian of the Supreme Court's law library, no one knew of any special rules. Nonetheless, MANY other States have special rules for people (not attorneys or other corporate persons). Those States including Ohio, Florida, and North Carolina, charge no fee (**since justice is suppose to be free to people. If I could call the police to have them stop the crimes being perpetrated against me I would not be charge anything but the police do not understand the laws being violated against me**), or they charge a miniscule fee like \$10 dollars. Since it is unclear exactly how the Supreme Court of South Carolina will construe my document (a motion, a notice of appeal, a petition for a writ of certiorari, or just a notice of their duty to protect my human rights) it is impossible for me to determine what fee, if any, is going to be charged to me. Could you please let me know and I will forward that fee to you post haste.
