Pursuant to Rule 203(b)(1)(B)(iv), the undersigned asserts that there are multiple issues to be brought before the Court of Appeals.

1) The Defendant believes the Judge is in violation of Rule 501 Canon 3 (B)(5) because the Judge made multiple statements about how he personally felt about certain aspects of the Defendant's case. Therefore the Judge made a Bias & impartial judgment towards the Defendant.

2) The Defendant believes the Solicitor and/or the Defendant's Attorney violated his Brady Law because the Solicitor spoke about lab results during his plea that the Defendant never received in any of his Discovery. The Defendant would have went to trial had he known about the lab results.

3) The Defendant was coerced into taking a guilty plea by his Attorney. His Attorney informed him multiple times that if he went to trial he was guaranteed a life sentence. The Defendant's Attorney also stated multiple times that if the Defendant chose to go to trial that his only defense for the Defendant would be that "the Defendant did society a favor." The Defendant's Attorney also consulted with the Defendant and stated that he spoke with the Solicitor and they agreed on a sentence with a 40 year cap if the Defendant would write a statement claiming full responsibility. As a result the Defendant declined his right to a jury trial and took a guilty plea and was sentenced to Life plus 5 years.

In conclusion the Defendant never knew about filing a motion to reconsider the sentence and was told not to object to anything. The Defendant ask that his appeal be accepted and be granted a new trial by Jury with a more sufficient Counsel.

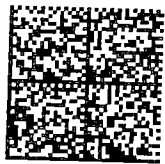
