APPELLANT'S MOTION FOR EXTENSION OF TIME

On August 3, 2016, the Court issued Unpublished Opinion No. 2016-UP-394 in the above-captioned appeal and affirmed the trial court. 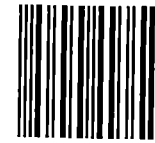
