APPELLANTS' MOTION FOR AN EXTENSION





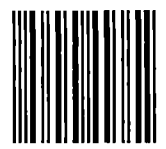
