
Motion

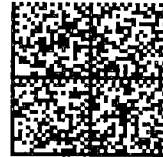
